

Instructions for Galleria Domain Two NFP Regular Membership Application

- * All required fields must be entered. Incomplete forms will not be processed.
- * Forms must be completed in a legible manner. Illegible forms will not be processed. This form is available as a PDF file with fill-in capabilities. You may open the file with Adobe Acrobat Reader, type in the required information and print the form. If this option is not available, be sure to print legibly.
- * Entering false information may result in a rejection of the application and a permanent ban from Galleria Domain Two NFP.
- * Signing a name other than your own may result in a rejection of the application and a permanent ban from Galleria Domain Two NFP.
- * All four pages of the application must be returned to Galleria Domain NFP to ensure processing. Do not include this instruction page.

Part One - Membership Application

All fields must be entered in Part One of the form.

Address listed must be that of current residence. If address does not match that listed on identification to be presented at door of Galleria Domain Two NFP, contact MztrsCarol at MztrsCarol@aol.com. (Acceptable forms of identification include driver's license, State ID, passport and military ID.)

Post office boxes may not be used as addresses.

Part Two - Payment Information

One payment type must be checked.

The card number, expiration date and CV code must entered for credit card payments. (CV codes may be found on the front of American Express cards and on the back of all other cards.)

Cardholder must sign and date form for credit card payments. If the payee is a person other than the applicant, the payee must sign.

Part Three - Membership Agreement

All 3 boxes must be checked at conclusion of member agreement on page labeled Page 4.

Part Three: Membership Agreement

Galleria Domain Two agrees-----

1. To provide clean, well-maintained space and equipment at all times for all members, as well as to provide all amenities listed as "membership privileges" unless otherwise changed (with notice to members). Galleria Domain Two does reserve the right to change policies at anytime deemed necessary and will inform members of any such changes in writing or by posted signs within the Galleria Domain Two facility.
2. To consistently urge members to give us their constructive as well as positive feedback so that we may continually meet their needs and desires as an organization and to provide specific forums to acquire and listen to your feedback.
3. To be committed to the personal growth, safety and education of both its current members and potential new members through the facilitation of workshops, seminars, symposiums, classes, trainings and demonstrations within the Galleria Domain Two facility.
4. To remain nonpartisan to any particular group, organization or entity as pertains to our chosen lifestyle, to accept all members who wish to participate in consensual, safe power exchange and roleplay.
5. To continually make special efforts and accommodations for the safety of all, and particularly to assist unpartnered members in socializing with like-minded others within our Domain.
6. That all information provided to Galleria Domain Two shall remain the sole confidential property of Galleria Domain Two never to be shared or sold.

You, as a Galleria Domain Two member agree -----

1. To uphold and adhere to all of the policies and guidelines set forth in this agreement as well as any future changes that may be implemented by the board of directors Galleria Domain Two as we grow as a community, and to participate within our community in any capacity that may further the growth, education and safety of others.
2. That these are the policies which you understand, agree to and acknowledge that violation of these policies will result in loss of membership privileges:
 - a. Soliciting anyone at anytime within the Galleria Domain Two facility for the purpose of exchanging funds for any services or goods without the express written consent of Galleria Domain Two is strictly forbidden.
 - b. Revealing names of other members or any activity that has occurred on the premises of Galleria Domain Two.
 - c. Filming or photography equipment is not permitted inside the facility without prior arrangements and consent from Galleria Domain Two.
 - d. Bringing in or harboring in any way alcoholic beverages, illegal substances or contraband to the Galleria Domain Two facility is forbidden, as is entering the premises while under the obvious influence of same. Further, Galleria Domain Two staff reserves the right to refuse admittance to and/or banish from the premises any person determined to be under obvious influence of any alcohol or substance.
 - e. To be cognizant, courteous and respectful of all members and guests while inside the Galleria Domain Two facility, whether inside roleplay rooms, social areas or private areas. You further agree to refrain from, as well as report any, behavior, which is either unsafe, inappropriate, rude, bothersome or disrespectful (i.e.; a polite "no thanks" means NO!).
 - f. You agree to use each area for its intended purpose. Scene rooms are for scenes. The Fireside Lounge is for food, beverages, smoking, elevated conversation and laughter. Bathrooms are for lavatory use

and dressing. Showers are for one person showering only. Equipment is for scene-use only, furniture is for sitting. While in scene rooms you agree to observe with your eyes only and with a lowered voice level, as well as proper distance from any scene. You agree not to interrupt, join uninvited, touch anyone (or yourself in an inappropriate manner) or cause disruption to any scene. Seating is provided in the scene rooms for observing. The Fireside Lounge serves soft beverages in glassware; we ask that feet be covered while in the lounge; glasses sometimes break and you walk barefoot at your own risk. Plastic glasses are to be used in the scene rooms. Smoking is not permitted in the scene rooms. Cigar smoking is prohibited in all areas. We ask that you bring a towel to sit on Lounge furniture if genitalia is exposed, particularly after scening. "Light" scening is acceptable in the Fireside Lounge (i.e. verbal, collar/leash, kneeling, servitude, etc). Take heavier scenes to the scene room. There are no DRESS CODE restrictions anywhere in the facility.

- g. There are two separate scene rooms, each geared to two specific types of scenes. The scene rooms are names "Serenity" and "Turmoil". "Serenity" will have softer music and an overall sensual erotic laidback atmosphere for "lighter" scenes. "Turmoil" will have louder, more upbeat techno music and is geared to more vocal and heavier scenes. You agree to be courteous to others by choosing the scene room most appropriate.
3. I understand and agree that all monies paid to Galleria Domain Two are funds which are for upkeep and cost of the club and its facility and that dues and donations are non-refundable and non-transferable for any reason, regardless of my intention and/or ability to attend Galleria Domain Two facility and/or events; and further, I understand and agree that it is possible at any time for Galleria Domain Two to, without notice, disband and/or dissolve as a club and/or the facility may be closed without notice.
4. I understand and agree it is my responsibility to update my e-mail address, telephone number and home mailing address so I may continue to receive billings and/or information from Galleria Domain Two.
5. By consequence of perjury in a court of law, I do understand and agree that by visiting the Galleria Domain Two facility I am knowledgeable that events may involve full or partial nudity by some of the participants and I will not be offended by this sight; and further, I declare that I am not attending events or joining Galleria Domain Two in any official capacity as an employee of, or agent for, and federal, state or local law enforcement agency for the purpose of obtaining evidence in any future or pending civil or criminal case of action, nor am I an official employee, freelance agent or agent of any news or media source and that all events I participate in or witness shall remain confidential: and further, that I am of legal age in the state of Illinois (21) and that the photo identification I present/ed is a true and accurate representation of my identity.

RELEASE OF LIABILITY

2. I understand that bondage and sadomasochistic activities involve certain real and unpredictable risks. I am cognizant of the risks and dangers inherent with the activities in which I and others will be participating and acknowledge that I am physically, mentally, emotionally and psychologically fully capable of participating in the activities and/or observing these activities.
3. I understand and agree that any bodily injury, dismemberment, death, or loss of personal property and

expenses as a result of my own intentional or negligent act(s), or the intentional or negligent act(s) of any other person(s) participating in any scheduled and planned, or unscheduled or unplanned activity, or as a result of the failure or malfunction of any piece(s) of equipment or devices, is my responsibility and I accept same. I also state and acknowledge that the activities associated with bondage and sadomasochism involve risk of injury from or resulting in bruises, contusions, lacerations, scalding and burning and severe contortion of the human body and that the foregoing list of possible injuries and injurious acts is neither complete nor exclusive.

I understand that accidents may occur, mistakes may be made, equipment and devices may fail or malfunction and that the premises in which I desire to participate in bondage and sadomasochistic activities do not include medical facilities and that injuries may be aggravated by delay in receiving medical attention. In consideration of the right to participate in bondage and sadomasochistic activities, and any other activities in which I may participate, I hereby certify that I am in good physical, mental, emotional and psychological health with no defects that might be injurious to me and that I am able to handle the hazards of bondage and sadomasochistic activities and any conditions that may be associated with such activities or with observation of these activities.

As partial consideration for being permitted to participate in and/or observe bondage and sadomasochistic activities, scheduled, planned, unscheduled or unplanned I hereby release from any legal liability and agree not to sue, claim against the property of, or prosecute and to indemnify and hold harmless Galleria Domain Two, it's associates, agents, assistants, guests, licensees and invitees, for any and all injury or death caused by or resulting from my voluntary participation in bondage and sadomasochistic activities and/or from injuries or any occurrence resulting from my choice to not read, disregard or ignore posted signs in, on or around the Galleria Domain Two facility.
6. I agree that if I create any descriptions or accounts of any activities occurring on the premises of Galleria Domain Two NFP in any way, I do hereby transfer any copyrights of any such materials to Galleria Domain Two NFP at this time by my signature below.
